Fair General Rules and Regulations

Entries:

1. County Exhibitors must be 4-H or FFA members of Polk County. 4-H'er or FFA member must be enrolled by May 15 of the current year.
 - Clover Kids – K thru 3rd Grade
 - Junior – Grades 4th thru 6th
 - Intermediate – Grades 7th thru 8th
 - Senior – Grades 9th thru 12th
 - FFA – Grades 9th thru 12th or 4 national conventions after high school graduation
2. The exhibit is an outgrowth of work done as a planned part of a project or program through 4-H or FFA.
3. Exhibitors in 4-H divisions are not eligible to exhibit in a similar division of FFA or vice-versa. Please communicate with extension or FFA staff for exceptions and clarifications. Polk County follows the state fair rules.
4. All fair entries, including Open Livestock, are to be made in [FairEntry](http://polkcountyfair.fairentry.com) (<http://polkcountyfair.fairentry.com>) before or on July 1 by 11:59 pm. No Paper forms will be accepted.
5. Late entries can be made for two business days following July 1. A \$50.00 per day fee will be assessed for late entries. After the 2-day late registration period, youth must contact the Fair board President to attend the Fair board meeting and ask permission to exhibit. Upon the Fair board's decision, a final fee will be decided.
6. All late entries have to be filled out in the office. Late entries must be paid in cash or check.
7. All exhibits will be under the control and general direction of the Department Superintendents.
8. The Polk County 4-H and FFA Fair Board will use every precaution to ensure the safety of animals or articles entered for exhibition after their arrival and placement, but in no case will they be responsible for any loss, injury, or damage to the same.
9. The Polk County 4-H and FFA Fair Board request the use of special precautions while using fans, radios, and other electrical equipment. All fans must have a protective covering or will not be allowed.
10. The only animals allowed in the sheep barn, horse barn, and Jacobson arena are animals being exhibited and certified service animals. All animals need to be contained or under control. Certified service animals need to be marked as such, this is an Iowa State Fairgrounds rule.
11. Animals must be owned by the exhibitor or immediate family member. All registration papers must be issued to exhibitor, family farm name.

Behavior & Conduct

1. All exhibitors and program participants are expected to be cooperative, courteous, and respectful 4-H or FFA representatives while on the fairgrounds and participating in fair events.
2. The Polk County 4-H and FFA Fair Board has adopted a policy of no alcoholic beverages or illegal substances at the County Fair by Exhibitors. The exhibitors' use or possession of alcoholic beverages, drugs, or smoking at the fair will disqualify the exhibitor's entry(s) and discontinued participation by the exhibitor.
3. 4-H and FFA members will NOT be allowed to remain at the fairgrounds overnight without adult supervision on the grounds.
4. Any cause for concern should be verbally addressed to the Department Superintendent. If the complaint is not satisfactorily resolved, a protest should be given, in writing, to the Department Superintendent from which the complaint arises. The Executive Committee on the grounds reserves the right to interpret all rules, and their decisions will be final. All protests and Executive Committee action will be reviewed by the Polk County 4-H and FFA Fair Board at their next regular meeting.
5. No bikes, scooters, rollerblades, skateboards, water balloons, or water fights are allowed in barns or 4-H exhibit building at any time. Fireworks of any kind are not allowed on the fairgrounds.
6. Any violation of the General Rules and Regulations or anyone who engages in unruly acts, vandalism, malicious treatment of livestock, or any other behavior that could cause injury to people, animals, or property, or disrupts fair activities should be reported to the general superintendent and action will be taken by the review committee on all cases. This will result in the forfeiture of all privileges, special recognition, and premiums. Livestock will be removed from the fairgrounds immediately.

7. Iowa Youth Code of Ethics will be enforced. Each youth agrees to these terms when they enter classes through FairEntry.

Premiums & Awards

1. Blue, red, and white ribbons will be awarded. Ribbons will be awarded on the merit of the exhibit, regardless of the number of exhibits in the class. The decision of the judge shall be final. Participation ribbons will be given in the "Fun" and "Open" Classes.
2. Only one ribbon will be awarded per entry.
3. Any premium check not submitted for cash within 90 days **will not** be reissued.

Livestock

1. FFA livestock must be identified using the 4-H LS106 series by May 15, including Breeding Beef, Sheep, Dog, Dairy, Dairy Goat, and Horse.
2. 4-H livestock must be identified in 4Honline by May 15, including Breeding Beef, Sheep, Dog, Dairy, Dairy Goat, and Horse.
3. Market Beef, Sheep, Swine, & Meat Goats - County weigh-in dates.
4. No cattle or horses will be allowed in the barns before 8:00 AM Saturday.
5. Sheep, goats, and swine are not allowed in barns until Sunday 5:00 AM. These animals must go through vet check in the Rock Island Parking Lot, south of the sheep barn before unloading.
6. All livestock must be checked in and weighed in according to the Livestock Weigh-in and Check-in Schedule. All exhibits (livestock and non-livestock) must be in their assigned area and will be released Thursday at 5:00 PM. The only exception will be cats, dogs, pets, open class animals, and animals shown as a pet during conference judging. They are released immediately following their respective shows.

Livestock Rules and Regulations

(Also see fair general rules & regulations)

1. All exhibitors must furnish their feed, bedding, feed, and water buckets for their exhibits, NO STRAW ALLOWED. Cattle will use wood chips only for bedding provided by the beef department.
2. All pens will be cleaned out on dismissal, or premiums will be withheld, and the exhibitor will be charged a fee of \$100 per pen or stall. All bedding material must be removed from your pen and from underneath adjoining pens.
3. A locked box for show equipment is recommended. Please label all equipment.
4. Advertising, such as personal names, club names, etc., is not allowed on show ring equipment.
5. All market animal weigh-in weights will be final once the animal has left the scale.
6. Exhibitors must wear only white or gray Polk County Fair T-shirts, 4-H T-shirts, or FFA T-shirts. Long jeans and closed toe shoes must be worn by exhibitors in the show ring. No hats, shorts, or ripped jeans of any kind allowed (*Exception: Horse department rules regarding dress and helmets.*)
7. All livestock must be shown by the exhibitor who enters it, except in cases of illness or two exhibits in the same class. Substitutes must be eligible Polk County 4-H or FFA members exhibiting at the Polk County Fair. Department Superintendent needs to be notified before the show.
8. Only exhibitors and officials are allowed in the show ring at the time of judging.
9. Any artificial means of removing or remedying physical defects or conformation in animals giving evidence of such treatment will be barred from the exhibition.
10. All entries must be in place as noted in "Livestock Weigh-In and Check-In Times."
11. All exhibits must remain in the assigned pen, cage, stall, or booth until release time of 5:00 PM Thursday unless stated otherwise in department rules.
12. All beef, sheep, swine, dairy, dairy goat, meat goat, poultry, and rabbit exhibitors must be YQCA certified to show. Contact Extension Office for YQCA certification.
13. Cattle, Sheep, Swine, and Meat Goats must have a Drug affidavit turned in at fair weigh-in.
14. Purebred registration papers must be submitted to the Superintendent at the Fair to be eligible. Registration Papers need to be in the exhibitor's name, farm name or immediate family member's name. Immediate family members include spouse, child, sibling, parent or legal guardian.

Health Requirements for Exhibition of Livestock, Poultry and Birds at a County 4-H/FFA Fair

Any evidence of warts, ringworm, footrot, pink eye, draining abscesses, or any other contagious or infectious condition will eliminate the animal from the show.

Individual Certificates of Veterinary Inspection will be required on livestock or poultry exhibited at a county 4-H/FFA fair and must be inspected when unloaded or shortly after that by livestock superintendents. Superintendents will require health certificates at check-in time, or the animal will be removed from the fairgrounds. Each show must have an official veterinarian. Health Certificates must be issued within 30 days (14 days for sheep and 7 days for swine) of the county fair. Quarantined animals or animals from quarantined herds cannot be exhibited.

Swine - No testing is required for swine at an exhibition that involves only market classes, provided all swine are consigned directly to a slaughter establishment from the exhibition. Commercial gilts may be taken home subject to state health rules and regulations.

Sheep and Goats - All sexually intact sheep must have an individual Scrapie Flock of Origin identification tag. All sexually intact goats must be identified with an individual Scrapie Flock of Origin identification tag or by an official tattoo registered with USDA (to register, call 1-866-USDA-TAG). Wethers over 18 months of age must have a scrapies tag.

Poultry and Birds - All poultry exhibited must come from U.S. Pullorum-Typhoid clean or equivalent flocks and have had a negative Pullorum-Typhoid test within 90 days of public exhibition performed by an authorized tester. Broilers must be within 30 days of the exhibition. All testing must be completed by the start of the fair and will not be done on the grounds. Superintendent will review certificates at check-in.

Dogs and Cats - All dogs and cats exhibited must have a current rabies vaccination certificate. Cats must have been vaccinated before July 1 with the vaccination number listed on the entry form. You will be required to present your current rabies certificate at the scheduled check-in time.

The decision of the official show veterinarian will be final.

These are the requirements as of February 2023, subject to change with the release of 2023 regulations.

Herdsmanship Contest

Superintendent: Becky Stock
Committee: Fair board Members

1. All 4-H clubs and FFA chapters with entries in the following departments will compete for Herdsmanship awards: **Beef & Dairy, Dairy Goats, Meat Goats, Horse, Rabbit/Cavy, Sheep, and Swine.**
2. Ribbons will be awarded to clubs for Herdsmanship awards.
3. Horse displays do not include banners, ribbons, and awards other than 4-H or FFA.
4. All alleys are to be kept clean. Paper decorations on stalls are permitted but should be kept neat and orderly.
5. Judging will be done periodically by a committee, according to the following scorecard:

Auction - Livestock

Superintendents: Ben Shivers, Amy Weldon, Nick Griffieon, Trevor Gallagher, James McDaniel, and Greg VandeLune

The Livestock Auction provides an outlet for the 4-H and FFA youth to sell their livestock. The Polk County Fair Board is not responsible for securing buyers or prices for the livestock. That is the responsibility of each youth.

1. All animals to be sold must have been exhibited by the 4-H or FFA members in their respective departments.
2. Exhibitors will be limited to selling a maximum of four beef animals in the sale in addition to Advanced Cattle Feeder Pens. Exhibitors must report the ear tag numbers of all of their auction animals to the department superintendent before the end of their respective shows.
3. The sale begins promptly at noon Friday.
4. Exhibitors must be present for the auction or make prior arrangements with the Species Superintendent, or premium will be withheld.
5. Sheep and Meat Goats weighing less than the minimums required by the packer will not go through the auction.
6. Sheep, Beef, and Meat Goat use weigh-in weights
7. Auction begins at noon Friday.
8. SALE FEE: 1% of the total auction amount will be deducted from the 4-H/FFA member's check.
9. 4-H/FFA members are responsible for processing and delivering the rabbits and poultry to the buyer.
10. All Sales are Final. See rules in the livestock office when entering your animals for sale.
11. Each Species will be released by the Sale Clerk.
12. Cattle, Sheep, Swine, and Meat Goats must have a Drug affidavit turned in at county fair weigh-in.

Skill-A-Thon

1. Teams consist of three members of youth in the same age range. Individual entries will be accepted.
 - a. Pee-Wee- K-3rd grade
 - b. Junior- 4th-6th grade
 - c. Intermediate -7th-8th grade
 - d. Senior- 9th-12th grade
2. This contest covers the understanding and practical application and the principles of Animal Science related to the dog, pet stock, poultry, rabbit, horse, dairy goat, beef, sheep, swine, and meat goats project areas.
3. Each youth will be given an answer sheet with their contestant number on it.
4. Youth will be split amongst the table and will not be with their teammates.
5. Youth will have 5 minutes at each table to answer questions or identify what is needed at each station. Pee-Wee- 2 answers, Junior- 5 answers, Intermediate- 8 answers, Seniors- 10 answers
6. Prizes and ribbons will be awarded to top teams and individuals.

Supreme Showman Contest

Committee: Sondra Feldstein, Amy Weldon, Deb DeDecker, Caitlin Remington, Trevor Gallagher, and Taylor Brittain

Supreme Showman will be held in Jacobson Arena Thursday at 1:30 p.m. or immediately after the conclusion of Bacon Buddies, whichever is first.

1. The Master Showmanship winner in the following species will be eligible to compete for Supreme Showman: Beef, Dairy Goat, Horse, Meat Goat, Sheep, and Swine.
2. If an exhibitor wins Master Showmanship in more than one eligible species, he or she will choose which species to represent, and the Reserve Showmanship winner will be eligible to represent the other species.
3. Department Superintendents are responsible for providing the necessary number of animals for the contest.

4. No exhibitor will be allowed to handle their animal, nor an animal belonging to a family member in the Supreme Showman contest.
5. All contestants will be required to submit a written biography before the competition, to be read aloud during the introduction of contestants.
6. The following criteria will be considered in the selection of Supreme Showman:
 - a) Exhibitor's ability to safely handle each species and show the animal to advantage.
 - b) Exhibitor's ability to answer questions put by the judges.
 - c) Exhibitor's show ring appearance and attitude.
7. Exhibitors will wear blue jeans, appropriate footwear, and t-shirts provided by the Committee. Exhibitors will display back numbers as provided. No hats will be worn.
8. Exhibitors will be supplied with all equipment needed to show each species.
9. Species will be shown as a class with the exception of horses.
 - a) For Horses: Exhibitors will be handed the showmanship pattern for horses after they have received their assigned animal. They will have two minutes to study the pattern and ask questions of the judge. The horse showmanship winner will go last.
10. Judges will be arranged by the Committee and will be qualified adults.
11. Contestants will be placed 1-6 in each species, and the Supreme Showman winner is the contestant with the highest number of points. Before the commencement of the contest, judges will decide on a tiebreaker. Judges' decision is final.
12. Once selected as Supreme Showman, an exhibitor will not be eligible to enter the contest in later years, even if they win senior showmanship again or in a different species. In that event, the Reserve Showman will enter the Supreme Showman contest as a regular contestant.

1. Entries and dress code - See General and Livestock Rules and Regulations for additional information.
2. Animals sold early or left at home will be discounted in the on-hoof judging but will be considered in the final record evaluation with premiums paid.
3. Ribbons and trophies will be presented at the fair based on the following scorecard:
 - a. Appearance
 - b. Uniformity and finish
4. Number of heads per pen 4.
5. The animals will be exhibited, graded, and sold according to plans developed by the Advanced Feeder Superintendent.
6. Pens of Heifers will be judged separately from Pens of Steers.
7. Excess mud and manure must be removed from cattle before weigh-in, or cattle will not be eligible for a rate of gain.
8. Exhibitor may show a pen calf as an individual halter calf but must specify at the December Weigh-in. The calf must be sold as part of the pen and not as an individual.
9. All advanced feeders must be placed by 8:00 AM Saturday unless prior arrangements have been made with the advanced cattle feeder superintendent.
10. All exhibitors must be present at auction for livestock to be sold unless arrangements have been made before sale with the advanced cattle feeder superintendent.
11. All Cattle must be dehorned before they arrive at the Polk County Fair.
12. All cattle must have a completed drug affidavit at the time of check-in at the Polk County Fair. It can be found on the Polk County Fair Website or picked up at the extension office.
13. ALL cattle that are showing as Polk County Produced need to have a Polk County Produced Affidavit turned in to the extension office. Affidavits for Market animals are due at weigh-ins. Affidavits can be found at the extension office or on the [Polk County Fair Website](http://polkcountyfairiowa.com/forms) (polkcountyfairiowa.com/forms)
 - a. Polk County Produced is defined as the animal is born in Polk County.
14. Record book will be required for each pen entered. Exhibitors not completing the record book will not be eligible for awards or sales.

Beef Department

1. Only supplied wood chips are allowed for bedding.
2. Entries and dress code - See General and Livestock Rules and Regulations for additional information.
3. Champion ribbons will be given out at judge's discretion.
4. Note weigh-in and check-in times at the front of this fair book.
5. All beef cattle must be in place by 7:00 PM, Sunday. (Only exception class 9 bucket/bottle class - see time below.)
6. All cattle must remain stalled until the release time of 5:00 pm Thursday.
7. All cattle must be dehorned before they arrive at the Polk County Fair.
8. All cattle must have a completed drug affidavit at the time of check-in at the Polk County Fair. It can be found on the Polk County Fair Website or picked up at the extension office.
9. ALL cattle that are showing as Polk County Produced need to have a Polk County Produced Affidavit turned in to the extension office. Affidavits for Market animals are due at weigh-ins and breeding animals are due May 15. Affidavits can be found at the extension office or on the [Polk County Fair Website](http://polkcountyfairiowa.com/forms) (polkcountyfairiowa.com/forms)
 - a. Polk County Produced is defined as the animal is born in Polk County.
10. All cattle must have an official ID for cattle options include:

Market Beef

1. Market beef must be weighed in and ear-tagged at the Polk County Weigh-in or accommodations made to attend another county's weigh-in.
2. An exhibitor may enter a maximum of four head of market beef animals.
3. All breeds and crossbreeds will show together in classes by weight.
4. Market cattle will be placed on individual merit from a market standpoint, taking into consideration conformation, quality, finish and rate of gain.
5. The order of the show will be posted before the show (check with the office in the livestock building).
6. Rate of Gain of 2.2 lbs. /day or better for Market Steers and 1.8 lbs. /day or better for Market Heifers is required to receive a blue ribbon.
7. The Champion and Reserve Champion market heifers and market steers will compete for Supreme Grand Champion Market Animal and Reserve Supreme Grand Champion Market Animal at the end of the market show. 3rd place market heifer and market steer will need to be on hand to place the top 5.
8. Top 5 will not be awarded for Polk County Produced.

Rate Of Gain

1. Awards will be presented to the top two entries having the highest rate of gain.
2. Rate of gain will be figured based on the official starting weight recorded at the time of ear-tagging and the weigh-in at the County fair. Excess mud must be removed before weigh-in to be considered for the rate of gain.

Breeding Beef

1. An exhibitor may enter a total of four animals in this department. A cow and calf are considered as one animal.
2. All animals will be judged based on breed characteristics, type, quality, and conformation with future usefulness as a breeding animal considered.
3. The Champion and Reserve Champion breeding heifers will compete for Supreme Champion Female and Reserve Supreme Champion Female at the end of the breeding show. Supreme Champion Female will not be awarded during Polk County Produced.

7. Performance Combination Class (#112 and #113)

General Rules

1. **Check-in and measurement will be held at 4 p.m. Saturday in the warm-up arena.** All exhibitors at check-in will be asked to verify stall numbers & emergency phone numbers. All equines must be accompanied by a certificate of veterinary inspection with individual identification, or a description of the individual animal listed and dated within 30 days of the county fair. Exhibitors will receive their exhibitor numbers at check-in.
2. **A REQUIRED exhibitor meeting will be held in the warm-up arena following horse check-in Saturday evening.**
3. Unless otherwise addressed in this rulebook, "Rules and Regulations for 4-H Equine Shows in Iowa" is available online (<http://www.extension.iastate.edu/4hfiles/agriculture/4H511CEquineRulesRegOnline2013.pdf>) will be followed. Some of the more important rules are restated in this (county) rulebook, but not all rules are reprinted here. Exhibitors are advised to consult the state publication for class descriptions, judging standards, code of conduct, and legal equipment for performance and games divisions.
4. Judge's decision is final.
5. Exhibitors must present the equipment for inspection when requested by show officials. Use of illegal equipment may result in dismissal from the show, disqualification, and forfeiture of premiums, ribbons, and other prizes.
6. An exhibitor is limited to entering and showing ONE (1) animal in a class and may not exhibit more than FOUR (4) animals at the fair.
7. Under state rules, siblings may co-identify multiple horses. However, if they share more than one horse, they may not show the same horse in the same classes regardless of age division, e.g., if one sibling shows in junior barrels, the other sibling may not show the same horse in senior barrels. In cases where siblings share only one horse, there is no restriction on which classes they may enter.
8. **No** stallions, weanlings, or foals may be shown or brought to the fair.
9. All juniors (those who've completed grades 4-6) and any first-time Polk County horse exhibitor, regardless of age or experience, MUST attend THREE Polk County 4-H/FFA clinics (or professionally held and paid for clinics*) to be eligible to show at the county fair (first-time exhibitors older than grade 6 may be excused from further requirements after coming to one clinic if superintendents are satisfied as to exhibitor's ability to ride and control their animal). *Contact must be made to superintendent(s) prior to clinic to obtain necessary forms for completion by clinician.
10. Leased horses may be shown in halter at the county fair. THIS RULE DIFFERS FROM THE STATE SHOW.
11. Only exhibitors and immediate family members, local club leaders, assistant leaders, or project leaders may assist with grooming and fitting animals at the show. A 4-H/FFA exhibitor may not be coached by any trainer on the Iowa State Fairgrounds during the Polk County Fair.
12. Only exhibitors may ride horses or ponies on the fairgrounds during the fair. If, for safety reasons, a parent or leader believes an animal needs lunging by an adult, please see the superintendent or a horse committee member.
13. **No** coaching or other assistance to exhibitors in the arena during a class. This includes verbal cues to the horse or pony. There will be one (1) warning from show officials. The next violation will be disqualifying the exhibitor and the animal and forfeiting premiums, ribbons, and other awards.
14. No exhibitor may be tied or fastened in the saddle, in any manner, while on show grounds. Anyone violating this rule will be dismissed from the show and forfeit all ribbons, premiums, and other prizes.
15. No dumping manure in garbage cans. All manure must be carried outside to designated piles.
16. No riding double at any time.
17. No riding in the barn at any time.
18. No loping in the warm-up arena. One warning will be given by the superintendents, horse committee, or designated show volunteers. A second violation will result in immediate dismissal from the show and forfeiture of all prizes & premiums.

19. **STANDARD OF CARE:** Exhibitors are required to provide wood shavings for stall bedding. ALL equines must be fed and watered each day, and their stalls picked clean, no later than 10 a.m. each day. All equines must be taken out of the stall for exercise at least once a day if not otherwise being shown. Two water buckets must be full at 9 p.m. each night, and stalls picked a second time. Failure to follow this standard of care will result in forfeiture of all premiums, ribbons, and other awards and may result in disqualification from further showing.
20. All horses and ponies are to be in their stalls at all times except (1) an exhibitor may exercise horses and ponies in the designated area(s) at times designated by superintendents; (2) an exhibitor may wash his/her horse or pony at any time with adult supervision; or (3) an exhibitor may tie the horse or pony in the aisle to prepare the horse or pony for the show so long as the exhibitor does not leave the animal unattended.
21. For purposes of classes at this show, all entries will be subject to measurement at check-in. Animals 57 inches or taller will be considered horses. Ponies must be less than 57 inches, or 57 1/2 inches if shod. POA cards will be accepted.
22. Exhibitors riding a pony may choose to enter either the pony division or the appropriate age division for the rider but must stick with one choice—you can't show as a pony in one class and a horse in another. The exception is games, where only age divisions are provided; exhibitors riding ponies in games should enter the rider's appropriate age division.
23. Stall cards must be attached to stall fronts and be filled out completely, including emergency phone numbers on the back of the card. DO NOT LOCK horse stalls. Tack stalls must also be marked and should be locked.
24. Questions about show conduct must be directed to show officials immediately. Once a decision has been reached, it is final.
25. Any exhibitor who needs to administer injections to a horse (e.g., allergy medicine) should talk to the superintendent first to avoid misunderstandings about drug use.
26. ALL EXHIBITORS will be required to help empty trash cans in the horse barn before the horse awards on Thursday.
27. Animals must remain in place until 5:00 PM Thursday. Any animal that leaves the grounds before that time will forfeit all ribbons, premiums, and prizes, except in cases of a medical emergency as determined by a veterinarian and cleared with the superintendent. Stalls must be cleaned and swept out at check-out time, and bedding must be completely removed and placed four feet from the wall in the aisle. Stall cleaning may begin at release time, and stalls must be inspected before leaving fairgrounds, or premiums will be forfeited. Leave stall card in place until inspected by a superintendent or horse committee member.
28. Violations of ANY rule(s) may result in premium & prize forfeiture and/or disqualification. (See General Rules and Regulations.)

Attire

1. An ASTM/SEI-approved headgear with a properly fitted harness and chin strap fastened is required at all times while mounted. No caps, hats, or scarves may be worn under the helmet. The Polk County Fair Association and Iowa State University make no representation or warranty, express or implied, about any protective headgear, and caution all riders that death or serious injury may result despite wearing such headgear as all equestrian sports involve inherent dangerous risk and no helmet can protect against all foreseeable injuries.
2. Hard-soled boots with heels and an approved helmet must be always worn when riding. Boots are recommended at all times. NO FLIP-FLOPS WHILE HANDLING HORSES.
3. Dress for exhibitors: western: long sleeve white or solid-colored shirt is preferred, also acceptable are: white tuxedo shirt or FFA jacket. Zip-up shirts are allowed at the county fair, THIS DIFFERS FROM THE STATE SHOW WHICH DOES NOT ALLOW ZIPPERED SHIRTS. Blue jeans only, no chaps. An approved helmet and heeled boots; ties and gloves optional. English: plain white or colored long-sleeved shirt or blouse, riding breeches, field boots, and an approved helmet. Paddock boots and half chaps are acceptable. (Jackets, vests, ties, and gloves are optional.) All shirts, English and western, shall be absent of beading, sequins, and other bling. No slip-on spurs.
4. Exhibitors will be issued two numbers. Numbers should be displayed on either side of the saddle pad during all riding classes and on the exhibitor's back during all in-hand and bareback classes. Failure to properly display the number will result in disqualification from the class.

5. FFA or 4-H armband worn on the left arm is required for all exhibitors. Failure to properly display the armband will result in disqualification from the class. 4-H armbands may be purchased at the Extension Office throughout the year or at the fair. FFA exhibitors, see your advisors for armbands.

Halter and Showmanship Classes

1. For halter and showmanship classes, either Western or English tack is acceptable. Western exhibitors in halter and showmanship must wear a cowboy hat. No cowgirl crowns. Exhibitors may use either a leather or nylon halter with a chain on the lead rope.
2. Exhibitors may win showmanship only once per age group. The Master Showmanship class is open to exhibitors who have already won an age division showmanship class in previous years and are ineligible to compete in that age division again. Current year's showmanship winners in each age division will also compete in Master Showmanship. The winner of Master Showmanship (or Senior showmanship, in the event that Master is won by an intermediate or junior exhibitor) will also compete in Supreme Showmanship on Thursday.

Performance and Game Classes

1. Age divisions are according to the last grade completed by the exhibitor, as follows:
 - a. Junior: 4th – 6th grade
 - b. Intermediate: 7th – 8th grade
 - c. Senior: 9th – 12th grade
 - d. Pony: animals under 57"
 - e. Collegiate FFA: FFA exhibitors who have started college. Separate classes will be provided if there are three or more collegiate FFA exhibitors in a class. Collegiate FFA is not eligible for high point awards.
2. Class sizes: entries per class are not limited. The show officials and judge reserve the right to split larger classes into smaller groups or combine classes to facilitate judging.
3. Exhibitors in timed games will mount outside the arena. If necessary, exhibitors may mount inside the arena but must do so without assistance, and the horse must remain under control at all times. Exhibitors will drop stirrups for inspection by designated gate officials before entering the arena. Once in the arena, exhibitors will wait until the gate is closed and the gate official gives the order before starting their run. Failure to wait for the order will result in a five-second penalty. Exhibitors must come to a complete stop and dismount before exiting the arena. THIS DIFFERS FROM STATE RULES in that we do not limit the number of circles an exhibitor may take before starting their run.
4. Only a parent, leader, or designated show official may assist the rider up to the gate. Adults may not enter the arena.
5. A five-second penalty will be assessed for each barrel or pole knocked down while riding the course in all game classes. Touching a barrel or pole is not a disqualification. Holding up or resetting a pole or barrel is not allowed.
6. No do – overs for the game classes, including cases of equipment failure.
7. Exhibitors who have conflicts will be accommodated as necessary. Otherwise, all exhibitors will run games in the order listed in the show book.
8. Attire for timed events: solid long-sleeve shirt with 4-H/FFA armband, or intact current Polk County Fair t-shirt. THIS DIFFERS FROM STATE FAIR, WHICH DOES NOT ALLOW T-SHIRTS.

Additional Class Information

1. Exhibitors entered in Novice classes may not enter any other performance classes. They may enter Timed Games classes.
2. Exhibitors must choose EITHER Ranch or Western for both Pleasure and Horse Walk/Trot, not a combination. No silver on tack and no fake tails for Ranch Horse Pleasure and Walk/Trot classes; banded manes are OK.
3. Exhibitors wishing to enter bareback classes for the first time must demonstrate to the Horse Committee's satisfaction their ability to stay on and steer their horse safely. Such demonstration will take place during pre-fair clinics or at a designated time at the county fair. Bareback classes will use equitation elements outlined in "Rules and Regulations for 4-H Equine Shows in Iowa."

4. Ranch Horse Equitation is a pattern class using **AQHA ranch riding patterns** and the judging standards for Ranch Riding. Exhibitors may enter Ranch Horse Equitation regardless of which pleasure class they enter (Ranch or Western).
5. All pleasure classes (English, Western, and Ranch) require riders to perform a controlled lope on a loose rein (see description of classes in "Rules and Regulations for 4-H Equine Shows in Iowa" available [online](http://www.extension.iastate.edu/4hfiles/agriculture/4H511CEquineRulesRegOnline2013.pdf) (<http://www.extension.iastate.edu/4hfiles/agriculture/4H511CEquineRulesRegOnline2013.pdf>)). If you and your horse cannot perform this maneuver, you don't belong in the pleasure classes. Exhibitors displaying excessive speed, passing with insufficient room, or otherwise judged to be endangering other riders will be asked to come to the center.
6. Exhibitors are advised to consult the state publication for class descriptions, judging standards, code of conduct, and legal equipment for performance and games divisions.

Awards

1. The judge may award Purple ribbons but will be treated as a blue ribbon for premium awards.
2. High Point/Reserve High Point awards will be given in each of the three age groups (Senior, Intermediate, and Junior) for English performance, Western performance, and timed games divisions. These awards will be given to the exhibitor and horse/pony combination, earning the most cumulative points in the division. All riding classes specific to the division and broken by the rider's age will count toward a high point.
3. The point system for rail classes (walk/trot and pleasure) and timed games will be as follows:

5. Tiebreakers: earned points in greatest number of events; greatest number of first place finishes; greatest number of purple ribbons; highest placing in western horsemanship/English equitation class OR for timed games, lowest total time.

Junior and Senior Cowgirl Queen Contest

1. No Premiums. No points.
2. Exhibitor must be a current 4-H/FFA member in Polk County to compete.
3. Attire is the same as all other Western classes.
4. Age requirements and rules will follow the Iowa State Fair rules for the current year. Junior Cowgirl exhibitors must be 10 to 15 years old as of January. Senior Cowgirl exhibitors must be 16 to 21 years of age as of January 1.
5. Winners must represent Polk County 4-H/FFA at the Iowa State Fair Cowgirl Queen Contest in August.
6. Exhibitors who have already qualified for Cowgirl Queen through another organization are welcome to enter the class and ride as exhibition only; you must pay the fee, but you will not be judged. If you qualify for the state fair AFTER entries are due July 1, you may still go ahead and ride as an exhibition only; you will not be judged.

2. Entries due July 1 (<http://polkcountyfair.fairentry.com/>). No Paper forms will be accepted.
3. See the show schedule for class numbers. This is not a 4-H class, so it is unnecessary to be a Clover Kids member to enter these classes.
4. Exhibitors may use a horse or pony that is entered for the Polk County Fair. Specify the name and club of the exhibitor whose horse you will be riding. If an exhibitor brings their own horse for open classes, it must have health papers, and it must arrive no earlier than noon on the day of the show and leave that evening. If the exhibitor puts the animal in a stall, stall must be cleaned completely before leaving.
5. Exhibitors who have completed kindergarten through 3rd grade may enter.
6. 4-H or FFA horse exhibitor must lead the exhibitor in the lead line class.
7. Parent or Guardian must be present during the show.
8. Fair Association is not liable for the injury. All exhibitors must have a liability waiver signed by a parent or guardian.
9. Exhibitors must wear a helmet, jeans, heeled boots, long-sleeved white or solid-colored shirt, or a current Polk County Fair t-shirt. 4-H/FFA members in the lead line class must follow the same rules for attire as in showmanship classes.
10. Exhibitors may enter all three classes.
11. Exhibitors in these classes may warm-up beginning at **5:30 PM Monday**. They may not ride at any other time during the fair.
12. **A mandatory Open Class exhibitor meeting will be held at 5:15 PM Monday. The exhibitor meeting will go over class, exhibitor, and spectator expectations for the Polk County Fair open classes.**

1. Bedding (Bring your wood chips, NO STRAW)
2. April/May Weigh-in: All Market lambs must be ear tagged with a county 4-H or FFA tag and weighed at the designated site **or approved alternative location by Polk County Youth Coordinator.** Lambs must come to the scale dry and without blankets, tubes, or leg wraps. Same with Member Produced Ewe lambs if entering them as a Scanned Individual.
3. Sheep needing special identification on the 4H-106d form are as follows: Sexually intact sheep with (a) date of birth (b) Flock # and scrapie #. (c) Member Produced Ewe lambs, Polk County Produced Lambs
a. Affidavit of Polk County or Member Produced Sheep form will accompany the above.
4. Penning Assignments will be posted outside of the office.
5. All sheep must have a completed Drug Affidavit at the time of check-in. Affidavits can be found at the extension office or on the [Polk County Fair Website](http://polkcountyfairiowa.com/forms) (polkcountyfairiowa.com/forms).
6. All breeding and market animals will be inspected, and health certificates checked by the Vet. **All animal birthdates must be on the certificate.** Lambs must come to the scale dry and without blankets, tubes, or leg wraps.
7. Any evidence of club lamb fungus, ringworm, draining the abscess, foot rot, sore mouth, or any other infectious disease will eliminate the animal from the show and be required to be removed from the fairgrounds immediately.
8. Sheep with signs of rectal prolapse will be released from the fair and be sent home based upon show superintendent discretion and overall health and welfare of the animal. A slight amount of rectal tissue that protrudes when the lamb is laying down but then retracts without assistance upon standing will not be considered clinical signs of prolapse for this purpose.
9. All pens MUST have at a minimum of exhibitors' names and clubs displayed above the pen.
10. Each animal can be entered in only 1 class except for pair of ewes, a pen of three market lambs, and a scanned lamb.
11. Each exhibitor is required to have one Scanned lamb (class 203) lamb must be shorn before weigh-in. May enter more if desired.
12. Exhibitors must add their lambs to the sale sheet in the office immediately after the show, and lambs must go through the auction.
13. All sheep must remain in pens until the release time of 5:00 PM Thursday. At this time, all sheep not selling at the auction must go home or have approval from superintendent.
14. All exhibitors will have assigned pens and must be cleaned by the exhibitor, or premiums will be withheld, and the exhibitor will be charged a fee of \$100 per pen.
15. Superintendent has the final decision on how all classes will be sorted at the fair.

Showmanship Contest

1. Exhibitors showing their livestock in all classes, including showmanship, can compete for showmanship awards.
2. Previous Junior and Intermediate winners are not eligible for this competition in the age divisions they have previously won.
3. Senior winner can go on to Supreme Showmanship that year.
4. Showmanship will be broken into three age divisions, as of September 1, previous year:
5. Master Showmanship class will consist of winners of this year and past years' Senior class winners, showing their livestock exhibited in a class in the current Polk County Fair.

Breeding Sheep

1. Breeding Sheep must be identified by May 15th on the 4H-106d Iowa Sheep Verification form or in 4honline with a birth date, flock, and scrapie number.
2. Entries in lamb classes must be born on or after Jan. 1, 2024; Yearlings shall be born on or after Jan. 1, 2023, through Dec 31 2023.
3. Ewes shown in breeding classes may not show in market classes and can only be shown as either commercial or purebred but not both.
4. All breeding animals must have a birth date at the time of entry on May 15. If a birthdate is not given at the time of entry the exhibitor will be allowed to show in the first class of the division but will not return for the champion drive. NO exceptions will be made.
5. Purebred animals (Rams and Ewes) will need registration papers in the name of exhibitor or immediate family at the weigh-in at the fair. If no registration paper, animals will be placed in commercial class.
6. All breeds of Purebred animals (Rams and Ewes) will all show together unless sorted out by the superintendent.
7. Rams and Ewes will be sorted in Purebred or Commercial and yearling or lambs if enough in each division.
8. Member Produced Ewe Lamb (a division of the ewe class) must be produced from an animal owned by a member or immediate family. May only show one animal in this class.
 - To be eligible for this class you must have all information filled out correctly in the Affidavit of Polk County or Member Produced Sheep form and turned in no later than the date communicated on the form. NO exceptions will be made for this class.
9. Any ewe lambs may also exhibit in class 109 (Pair of Ewes) and/or class 210 (Scanned Market lamb)

2. Each exhibitor is limited to showing six crossbred market hogs (barrows or gilts), six purebred market hogs (barrows or gilts), and one pen of three, four commercial breeding gilts, four purebred breeding gilts, and one litter.
3. Classes must be designated in FairEntry on July 1.
4. All hogs competing may be purebred or crossbred.
5. All hogs must be born on or after December 15.
6. All swine must be tagged on the Polk county tagging day.
7. All male swine must be castrated before the county tagging day.
8. All pigs must be ear notched. All pigs from a litter must have identical litter ear notch marks. Ear notch for litter must be done at birth. Pigs coming to weigh-in without notches will not be eligible for litter classes. No duplicate ear notches are allowed in the litter.
9. Exhibits of market gilts and barrows, commercial gilts, commercial purebred gilts, purebred market hogs, or market pen of three may be made from a litter project or non-litter entries or purchased feeder hog.
10. Purebred breeding gilts will be shown by age. They will also be weighed at fair check-in for sale weight.
11. Purebred registration papers must be submitted to the Superintendent at the Fair to be eligible. Registration Papers need to be in the exhibitor's name, farm name or immediate family member's name. Immediate family members include spouse, child, sibling, parent or legal guardian.
12. Showmanship Contest
 - a. Exhibitors showing their livestock in all classes, including showmanship, are eligible to compete for showmanship awards.
 - b. Previous winners are not eligible for this competition in the age divisions they have previously won.
 - c. Showmanship will be broken into three age divisions, as of September 1, the previous year:

Litter

1. The exhibitor must obtain the sow or gilt before she farrows. Hogs purchased after farrowing cannot be shown as a litter project.
2. A Market Litter will consist of a litter of six or more hogs farrowed by one sow.
3. Market Litters will be judged as follows: total weight of litter, number, and age considered, 50%; uniformity of quality from a market standpoint, 50%.
4. A litter of less than 6 market hogs cannot be entered and judged as a litter.
5. A market litter will have to average not less than 230 lbs. or more than 300 lbs. per hog to compete for Champion Litter.
6. If entries warrant, purebred litters may be in a separate class from commercial.
7. Ear notch for litter must be done at birth. Pigs coming to weigh-in without notches will not be eligible for litter classes. No duplicate ear notches are allowed in the litter.

Value Added Carcass

1. All swine must be identified on the specified county ID date in April.

2. All swine will be eligible for the Carcass class as long as they were tagged in.
3. Exhibitors will choose at least one pig for the carcass scan class and **MAY** scan all pigs.
4. Value Added Carcass will be scanned to determine backfat, loin eye, etc., and final Value-Added Carcass Class placing will be determined from scan data.
5. Trophies will be awarded to first and second place Value Added Carcass entries.
6. Value Added Carcass swine will be eligible for the auction.

Own, Breed, Born, & Raised Class (OBBR)

1. Project is made up of required documentation of ownership, breeding, gestation, farrowing, raising swine, and exhibiting at the county fair.
2. Open to all eligible 4-H and FFA members
3. The animals involved in this class need the exhibitor as the daily primary caregiver.
4. Photos are required at every stage of the project.
5. You will need one Sow Packet per sow.

Sow ownership

- Exhibitor must own and show ownership of the unbred sow or gilt by September 1.
- Refer to of OBBR Sow packet for full requirements.

Breeding

- Photos of the boar are required.
- It is the participants' responsibility to oversee the breeding process, whether it is natural or artificial.
- Refer to OBBR Sow Packet for full requirements.

Gestation & Farrowing

- Details of the farrowing are required.
- Refer to OBBR Sow Packet for full requirements.

Raising

- This section refers to birth to pre-fair activities.
- Refer to OBBR Sow Packet for full requirements.

Fair

1. All swine will be vet checked before unloading animals. Vet checks will run 5:00 am-8:00 am.
2. All vet-issued health papers must be within 7 days of the show.
3. Note the weigh-in times on the front of this book.
4. All Swine must have a completed drug affidavit at the time of check-in at the Polk County Fair.
5. If hogs are clipped, packer guidelines of hair at least one-half-inch in length must be followed.
6. All livestock must be in place by 9:00 AM, Sunday, the superintendent will determine classes after weigh-in.
7. The weigh-in weight will be used for the sale. Weight limits will be determined by the Auction Committee.
8. Only the market gilts and barrows weighing less than 230 lbs. will not be eligible to compete for the Grand Champion market hog.
9. Each hog will weigh separately, and each exhibitor will identify their hog classes (market gilt, market barrow, purebred market hog, litter, pen of three, commercial breeding gilt, purebred breeding gilt, and Value-Added Carcass).
10. Commercial breeding gilts or purebred breeding gilts cannot be shown as individual market gilts but can be shown in a pen of three, litter, or Value-Added Carcass.
11. Champions for the commercial gilt class are not subject to the 300lbs weight limit.
12. All hogs can be taken home subject to state health rules and regulations.
13. A market pen of three will be composed of three pigs, Commercial or purebred (either barrows or gilts), but need not be litter mated. Market Pen of Three will have to average not less than 230 lbs. or more than 300 lbs. per hog to compete for Champion Market Pen of Three.
14. Champion ribbons will be awarded if the judge feels the exhibit merits the award. The first two blue ribbons in the market gilt, market barrow, purebred hogs, and pen of three, commercial gilt, purebred gilt, and litter classes will compete for a division champion.
15. The division champions in the market gilt, market barrow, purebred market hog, and Value-Added Carcass classes will compete for grand champion market hog. The champion commercial gilt and champion purebred gilt will compete for the grand champion breeding hog.

16. Wash pens are for washing pigs only. Feeding livestock in the wash pens is not allowed. Exhibitors are encouraged to wash pigs and return them to their pens as quickly as possible to allow all exhibitors time to use the washing facilities.
17. Wash pens will be closed starting at 8:00 AM on show day, they will re-open over the noon break and close again when the show resumes. Animals exhibiting signs of distress will be allowed access to wash pens as determined by show officials.

1. Each exhibitor is limited to a maximum of 2 cats or kittens per class, not to exceed a maximum of 6 cats or kittens total entered. See General Rules & Regulations for more info.
2. Cat entries will be checked in from **2:00 – 3:00 PM** late arrivals will not be accepted. A **\$1.00 Veterinarian Fee** will be collected from each exhibitor at check-in time. Open Class Show starts at **3:30 PM**, with 4-H & FFA Cat Show to follow. Cats will not be housed at the fairgrounds. They are to be brought in and returned home the day of the show. Cats will be released by the Superintendent following the show and department clean-up.
3. Exhibitors must present a current rabies certificate for their cat(s) at the time of check-in at the fair. All cat(s) must have their rabies vaccination before July 1. Kittens, 4 months old, on the day of the show, can be vaccinated at 2 weeks before the show date. The decision of the show veterinarian will be final.
4. Toenails of cats on all feet, should be clipped just before fair. No pregnant, nursing, or mother cats may be shown.
5. Cats are to be brought to the fair in a well-ventilated, standard cat carrier (Pet Taxi) with a solid bottom and secure door. No wire cages or wire bottoms in cages are allowed. No cardboard boxes are allowed.
6. Cages will be provided during the show. The exhibitor is responsible for providing litter boxes, litter, and water bowls. Curtains or towels must be brought for each cage. The single dimensions are 25 ½" wide x 23" deep x 26" high. Every side and top (except front) should be covered. This is to make the cat feel more secure and help prevent the cat from attempting to get out of the cage. Exhibitors are responsible for taking down their cages after completion of the show and release of the cats. No premiums will be paid to exhibitors who fail to help with the takedown and clean-up of the cat show. Family members are allowed to help with the set-up and takedown.
7. Exhibitors must wear only white or gray Polk County Fair T-shirts, 4-H T-shirts, or FFA T-shirts. Long jeans and closed toe shoes must be worn by exhibitors in the show ring. No hats, shorts, or ripped jeans of any kind allowed. Wearing improper attire will result in lower ribbon placing.
8. The exhibitor must be present to handle the cat during the show and answer the judge's questions.
9. Only exhibitors and officials are allowed in the judging area at the time of judging. No cell phones or other devices will be allowed in the show ring area.
10. Cats or kittens will not be judged with ribbons, collars, or other identifying marks on necks or bodies.
11. The following awards will be given to 4-H and FFA exhibits Best in Show, Best Short Hair, and Best Long. A Champion Rosette will be awarded to the Junior, Intermediate, and Senior Showmanship Class winners.
12. **Cage Décor and Oldest Cat Award will be selected from 4-H, FFA. Open Class will be judged by itself for Cage Décor.**
13. Previous winners of the oldest cat Oldest Cats are ineligible. The age of the cat must be listed on the original entry form to be eligible for Oldest Cat. Listing the exact date of Birth is encouraged, as it could determine the winners. No changes to the age of the cat will be made at the time of the show.
14. All Cats and Kittens will be judged by the following scoring criteria:
 - a. Condition (30%)
 - b. Cleanliness (25%)
 - c. Grooming (20%)
 - d. General Appearance and Individuality (15%)
 - e. Disposition (10%)

Long Hair Classification

These classes are limited to kittens and cats with medium to long hair coats. Long-haired cats can be determined by looking at the cat's tail, the hair will be longer than normal and usually fluffy or plume-like. Refer to the Superintendent with questions.

8. Exhibitors must present a current rabies certificate for their cat(s) at the time of check-in at the fair. All cat(s) must have their rabies vaccination before July 1. Kittens, 4 months old, on the day of the show, can be vaccinated at 2 weeks before the show date. The decision of the show veterinarian will be final.
9. Toenails of cats on all feet, should be clipped just before fair. No pregnant, nursing, or mother cats may be shown.

Dog Obedience Department

1. Entries – A maximum of two dogs may be entered and all dogs must be pre-entered. All dogs must be 6 months old by July 1st.
2. All dogs must be on a leash at all times except in the show ring. Dogs may not be taken near the other livestock or into other exhibit buildings. Dogs must be clean and free of all parasites, diseases, and injuries. **No females in season may be exhibited.**
3. Dogs will not be housed at the fairgrounds. They are to check-in at 7:00 AM the day of the show and be removed immediately following the competition of judging. All dogs must be confined to the show area during the judging.
4. The classes will be judged by American Kennel Club (AKC) rules and regulations except for the classes open to mixed breed and purebred dogs. Handlers are to refer to the dress code under livestock rules and regulations. Shorts may not be worn.
5. Showmanship will be judged on proper presentation, including patterns, judge's directions, answering dog-related questions correctly, and the dog and exhibitors' ability to present a pleasing image. Dogs should be well-groomed.
6. Any dog displaying viciousness to a person, or another dog will be excused.
7. **Health Requirements:** Members must present a current rabies certificate during check-in at the fair.
8. All dogs will be health checked at the time of check-in by a County Fair Veterinarian for \$1.00 per animal. Any animal found in poor health or vicious will not be allowed to show and will have to leave the fairgrounds.
9. All dogs shall be trained and handled by the exhibitor without outside assistance.
10. All dogs in the obedience ring must wear a properly fitted collar. No special training collars such as electronic collars, prong collars, or head halters will be permitted. Nothing may be hanging from the dog's collar.

2. A (1) pet exhibit may be shown.
3. All pets must come properly restrained or contained. Appropriate examples include on a leash or in a box, cage, or bowl (cage supplied by owner).
4. No wild animals, No exotic animals, and No reptiles may be shown.
5. No poultry, geese, turkeys, ducks, pigeons, doves, guinea, pheasant, peafowl, or quail are shown here. They are shown in the poultry division.
6. Exhibitors may not show the same type of animal in two different shows. For example, an exhibitor may not show one rabbit in the pet show and another rabbit in the rabbit show.
7. All animals must be healthy at the time of the show. The same health requirements for each species' specific class/division will also apply to the pet show. Cats, dogs, and ferrets must have current rabies and/or distemper certificate. Vaccinations have required a minimum of 3 weeks before the fair for all small animals.
8. Pregnant animals will not be allowed to show. No animal with a nursing litter may be brought to the fair.
9. Kittens, dogs, and ferrets showed at the fair must be 4 months old and above.
10. Livestock animals such as swine, horses, cattle (beef and dairy), sheep, and goats are not to be shown in the Pet Show.
11. Small pets are released immediately after the show.
12. Judge has the option of removing pets from cages or asking the 4-H'er or FFA member to show and handle the pet.
13. Exhibitors must wear only white or gray Polk County Fair T-shirts, 4-H T-shirts, or FFA T-shirts. Long jeans and closed toe shoes must be worn by exhibitors in the show ring. No hats, shorts, or ripped jeans of any kind allowed.
14. Judging is based on the following information:
 - a. What is your goal in the project?
 - b. Necessary Veterinary Care of My Pet (including a vaccination certificate – if applicable)
 - c. Daily Care of My Animal
 - d. Cost of Pet and Daily Upkeep

6. No poultry, geese, turkeys, ducks, pigeons, doves, guinea, pheasant, peafowl, or quail are shown here. They are shown in the poultry division.
7. Exhibitors may not show the same type of animal in two different shows. For example, an exhibitor may not show one rabbit in the pet show and another rabbit in the rabbit show.
8. All animals must be healthy at the time of the show. The same health requirements for each species' specific class/division will also apply to the pet show. Cats, dogs, and ferrets must have current rabies and/or distemper certificate. Vaccinations have required a minimum of 3 weeks before the fair for all small animals.
9. Pregnant animals will not be allowed to show. No animal with a nursing litter may be brought to the fair.
10. Kittens, dogs, and ferrets shown at the fair must be 4 months old and above.
11. Livestock animals such as swine, horses, cattle (beef and dairy), sheep, and goats are not to be shown in the Pet Show. Please see individual departments for these animals.
12. Small pets are released immediately after the show.
13. No premiums paid (ribbons only).
14. Exhibitors must wear only white or gray Polk County Fair T-shirts, 4-H T-shirts, or FFA T-shirts . Long jeans and closed toe shoes must be worn by exhibitors in the show ring. No hats, shorts, or ripped jeans of any kind allowed.
15. Judge has the option of removing pets from cages or asking the 4-H'er to show and handle the pet.
16. Judging is based on the following information:
 - a. What is your goal in the project?
 - b. Necessary Veterinary Care of My Pet (including a vaccination certificate – if applicable)
 - c. Daily Care of My Animal
 - d. Cost of Pet and Daily Upkeep
 - e. How Does Your Pet Fit Into Your Family's Lifestyle?
17. All Animals will be health checked at the time of check- in by the Fair Veterinarian for a total cost of \$1.00 per family. Any animal found in poor health or vicious will not be allowed to show and will have to leave the fairgrounds.

- All poultry exhibited must come from U.S. Pullorum-Typhoid clean flocks and have had a negative Pullorum-Typhoid test within 90 days of public exhibition. If the birds came from a P.T. clean flock they will still need to be tested. Proof needs to be presented at check-in time. Testing will be available at the Polk County Extension Office before the fair.
1. Only Market Broilers and Market Turkeys can be sold at the Livestock Auction on Friday. Birds must be processed and delivered to the buyer by 4-H or FFA members. After the auction, the cages must be taken down and litter must be cleaned up by 4-H or FFA participants.
 2. When birds are released all cages must be taken down and all litter must be cleaned up by 4-H or FFA participants or premiums will be withheld.
 3. Poultry exhibit check-in is **4:00 PM - 8:00 PM, Saturday 7/13/2024**. **Broilers, Market Turkeys, and Open Classes** may be checked in between 6:00 – 8:00 AM the day of the show, Sunday **7/14/2024**. No substitutions may be made of any poultry exhibit after poultry have been entered except by the permission of a Poultry Superintendent. Substitutions, after Fair Entry has closed, are encouraged to be emailed to the superintendent for advanced approval so cages and cards can be adjusted in advance.
 4. Each exhibitor is responsible for proper entering and placing birds in pens; a Poultry Superintendent will assign pens.
 5. Each exhibitor is limited to **one entry per sex per variety per color**. (Example: An Orpington hen and rooster may be shown by the same participant but not two Orpington roosters or an exhibitor may show a black silkie pullet and a white silkie pullet but not two of the same color).
 6. Pens must contain birds of the same sex and age. Large/unusual exhibits may need special pen furnished by the exhibitor and approved by the superintendent.”
 7. Herdsmanship (judging care, cleanliness, and health of the animal) will be checked by the Herdsmanship Department, and ribbons provided to the exhibitors who merit awards.
 8. Exhibitors are responsible for the care (feed and water) of their animals and must sign the Poultry Pledge at check in detailing their commitment for the care of their birds.
 - Water should be checked several times each day. Exhibitors are responsible for providing their containers for feed and water.
 - Water containers are preferred to be attached to the pen so they cannot be knocked over.
 - Water must be entirely replaced every 24 hours at a minimum and inspected throughout the day.
 - Soiled bedding must be removed every 24 hours at a minimum.
 9. Poultry exhibitors must provide their bedding such as shavings or pelletized horse bedding. Sand is not permitted. It will be communicated prior to the fair if the bedding is provided for the exhibitor.
 10. Poultry, except Broilers and market turkeys remaining for the auction, must remain in cages until the release time of 5:00 PM Thursday **7/18/2024**.
 11. Showmanship Contest- Showmanship will be judged on the member's ability to properly handle their bird and answer the judge's questions regarding breed, poultry anatomy, general poultry knowledge, overall poise, and appearance. Showmanship classes are grouped by age.
 - a. Exhibitors showing their livestock in all classes, including showmanship, are eligible to compete for showmanship awards.
 - b. Previous winners are not eligible for this competition in the age divisions they have previously won but may compete in a higher age level. Once an exhibitor has won Champion at the Senior Showmanship Level than cannot continue to show in poultry but are encouraged to teach a class in showmanship to the Open Class the year after their win.

2. All rabbits must be permanently tattooed in the left ear. The tattoo must be on the fair entry form with the proper Class Number and the Rabbit's Tattoo.
3. All rabbits and cavies will be health checked at the time of check-in by the Fair Veterinarian for a total cost of \$1.00 per family. Any animal found in poor health or vicious will not be allowed to show and will have to leave the fairgrounds.
4. A rabbit showing evidence of the following conditions, at any time during the fair, will not be allowed to remain on the fairgrounds.
 - Snuffels - thick white or yellow discharge from the nose
 - Runny Eyes
 - Ear Mites
 - Diarrhea
 - Abscesses
 - Coccidiosis
 - Other health problems that could endanger any other animal.
5. Exhibitors will need to be YQCA certified.
6. Rabbit and cavies (guinea pigs) must be checked-in Monday between 1:00 -3:00 PM. Only rabbits and cavies entered in the show may be on the grounds.
7. All livestock must be in place by 3:00 PM Monday. (Exception: open class Tuesday 9 AM.)
8. All exhibitors must be present at 9:30 AM Tuesday for the exhibitor's meeting which will be held by the show ring.
9. Only meat pen and single fryer entries can be sold in the livestock auction. If entered in the auction the 4-H or FFA member must move the rabbits to the auction ring and tear down the cages and tables after the auction.
10. A copy of the American Rabbit Breeders Assn. (ARBA) standard of perfection is available at the Polk county extension office and current publications will be used as the guide for judging our show.
11. Bring your feeders, water containers, cleaning supplies, shavings, feed, fans, and drop cords. Drop cords must be duct-taped to the floor.

16. Showmanship Contest

1. A copy of the 4-H Rabbit Showmanship Score Sheet is available at the Extension Office. This form will be used to judge showmanship classes. Showmanship consists of rabbit/cavy handling procedure, exhibitor appearance, exhibitor knowledge, and rabbit/cavy appearance.
2. Showmanship judging will be on Tuesday at 8:00 AM by show ring.
3. Showmanship exhibitors may either use a rabbit or cavy for judging, but it must be entered in the Rabbit or Cavy Show.
4. To be eligible for any Showmanship awards, the exhibitor must show at least one Rabbit or Cavy in the Polk County 4-H/FFA Rabbit/Cavy Show.
5. Previous Showmanship Trophy Winners are eligible to compete in the Showmanship Class; however, any exhibitor may win a showmanship trophy only once in each age group.
6. The following awards will be given after the judging is completed on Tuesday.
 - a. Junior Showmanship Trophy
 - b. Intermediate Showmanship Trophy
 - c. Senior Showmanship Trophy
 - d. Overall Showmanship Trophy

4. Any Cavy showing evidence of the following condition at any time during the Fair will not be allowed to remain on the fairgrounds.
 - Abscesses
 - Cold-Nasal Discharge
 - Mange - dandruff or scale at the base of the hair
 - Mites, lice, or ticks
 - Runny Eyes
 - Other health problems that may endanger cavy or other exhibits.
5. Cavy cages are NOT available. The exhibitor is responsible for bringing their cage(s), waterers, feeders, and bedding. A cage table will be provided. Please note the size of the cage/Space needed.

1. Entry fees due July 1 at the Extension office Judging Time – Tuesday morning before the 4-H/FFA Rabbit/Cavy Show.
2. Each exhibitor must have their animal. Animals cannot be shared with other open-class exhibitors.
3. Any Polk County youth K – 3rd grade (as of July 1) may exhibit in this class.
4. Check-in 9:30 AM Tuesday before Rabbit/Cavy show. The exhibitor meeting will be at 9:30 AM by the show ring.
5. Exhibitors must wear only white or gray Polk County Fair T-shirts, 4-H T-shirts, or FFA T-shirts. Long jeans and closed toe shoes must be worn by exhibitors in the show ring. No hats, shorts, or ripped jeans of any kind allowed; they must also attach their exhibitor number on their back.
6. Any healthy Rabbit or Cavy (Guinea Pig) of any breed, variety, sex, and class may be shown. All entries MUST be Health Checked by Rabbit /Cavy Superintendent unless it has been done for the 4-H/FFA Show.
7. The Rabbit or Cavy does not need to meet breed standard requirements but must be a minimum of 10 weeks of age.
8. Exhibitors may enter 1 Rabbit and 1 Cavy for a total of 2 animals in this division.
9. The class may be divided into classes depending on the number of entries.
10. Each youth will be interviewed regarding the management and care of their exhibit.
11. Judging to be based on:
 - a. What the exhibitor has learned about the care of the Rabbit or Cavy.
 - b. The grooming and cleanliness of the animal.
 - c. General health, condition, and management of the animal.
12. No premium will be paid-Participation ribbons only.
13. Parent or guardian must be present during the show.
14. Fair board is not responsible for accidents or injuries.
15. Animals must be brought and kept in approved animal carriers and removed following the shows.
16. Cages for open show rabbits/cavies will be in a separate area- not connected to 4-H Club cages.
17. All rabbit and cavies will be health checked at the time of check- in by the Fair Veterinarian for a total cost of \$1.00 per family. Any animal found in poor health or vicious will not be allowed to show and will have to leave the fairgrounds.

- Family and Consumer Sciences (includes Child Development, Clothing, Consumer Management, Food and Nutrition, Health, Home Improvement, and Sewing), Agriculture/Animal/Natural resources, Creative Arts, Horticulture, Science/Engineering/Technology, and Personal Development.
- Fair general rules & regulations for additional information. A violation of rules may result in a forfeiture of all privileges, recognition, and premiums.
- The goal and applicable exhibit standards will form the basis of the evaluation process. Evaluation criteria will include demonstrated learning, workmanship and techniques, and general appearance and design.

4-H Exhibit Rules and Regulations

1. These departments are open to 4-H and FFA members in Polk County. Exhibits are the result of project work prepared within the last 12 months.
2. Exhibits can be prepared by an individual or group. Exhibits might be, but are not limited to, an actual poster, display box, report, notebook, model, videotape, etc. 4-H participants in 4-H special interest and school enrichment programs and/or 4-H community clubs in grades 4 -12 are eligible to exhibit. FFA members are eligible to exhibit but will not be selected to go on to State Fair.
3. Clover Kids may only enter exhibits in the non-competitive, Clover Kids Department.
4. All members of 4-H, FFA, Clover Kids, School Enrichment and Special Interest Groups must enter their exhibits [online](http://polkcountyfair.FairEntry.com/) (<http://polkcountyfair.FairEntry.com/>)
 - **Clover Kids – K-3rd Grade**
 - **Junior – Grades 4th-6th**
 - **Intermediate – Grades 7th-8th**
 - **Senior – Grades 9th-12th**
 - **FFA – Grades 9th-12th and until age 21**
5. **ENTRIES DUE DATE: July 1**
6. All fair entries including Open Livestock are to be made [online](http://polkcountyfair.FairEntry.com/) (<http://polkcountyfair.FairEntry.com/>) before or on July 1 by 11:59 pm. No Paper forms will be accepted.
7. Late entries can be made for 2 business days following July 1. A \$50.00 per day fee will be assessed for late entries. After the 2-day late registration period, youth must contact the Fair board President to attend the Fair board meeting and ask permission to exhibit at the fair. Upon the Fair board's decision, a final fee will be decided.
8. All late entries have to be filled out in the office. Late entries must be paid in cash or check.
9. **Entries must remain on exhibit until release time of 4:00-5:00 pm Thursday.** If you cannot be there to pick up your exhibit, arrange for a family member, friend, or leader to get your exhibits.
10. Clubs will be assigned a duty to complete during the fair. If your club is unable to complete the duty assigned, please find a group to switch with.
11. Clubs will be allowed to decorate their club booths from **5:30-8:00 pm** the Friday before the fair. Booth decorations need to be completed by **Noon** Saturday.
12. Exhibits that do not comply with size guidelines, copyright, and safety procedures will not be accepted for entry, evaluation, or display.
13. Each member can have an unlimited number of entries in each department.

Exceptions:

Visual Arts - 3 exhibits per medium

Horticulture - 2 varieties per class

Photography – 6 exhibits

An exhibit may be entered in only one class. (*Exception: Article(s) worn in Fashion Revue, Clothing Selection, or \$20 Challenge may also be entered in the related Clothing, Consumer Management, or Sewing Class. See the Clothing Selection Rules to determine the corresponding Family & Consumer Sciences Class*)

Fair Preparation

1. Exhibit Size:

- **Posters** may not exceed 24" x 36" in size. (See Classes 10490 and 10530 for smaller requirements.)

Charts, graph boards, model displays, etc. may not exceed 48" x 48" in size. Maximum size is determined by measuring the flat (unfolded) dimensions.

Display boxes cannot exceed 28" X 22" in height or width and 12" in depth.

2. Attach an entry tag to each exhibit. Entry tags are pre-printed and mailed. Tags correspond with the entry made in 4-H online. Please make sure the description of the entry is detailed.
3. Each exhibit is required to have a goal sheet. The required questions are as follows.

GOALS: Answers to the following questions about the exhibit must accompany the exhibit. (An audio cassette or videotape may be used (limited to 5 minutes)).

What was your goal(s)?

How did you go about working toward your goal(s)?

What were the most important things you learned as you worked toward your goal(s)?

What would you like to do in this project area next year?

Failure to attach responses to these statements will result in a lower ribbon rating. Exception:
Horticulture classes require only a general garden goal statement.

4. Photography and Communication Poster exhibits require an exhibit label attached to the entry. Labels are available on the Polk County Fair Website
5. Check for additional requirements in the following classes: Food & Nutrition, Photography, Communications, and Creative Arts.

Elements and Principles of Design are not required in a write up however it is recommended that youth can reference them, especially in Visual Arts and Clothing classes.

Art Principles

Principles of design are the directions or guidelines for mixing the elements. Principles included are balance, rhythm, emphasis, proportion, and unity.

1. Balance gives a feeling of stability. There are three types of balance.
 - Symmetrical: the elements used on one side of the design are similar to those on the other side.
 - Asymmetrical Balance: the sides are different but still look balanced.
 - Radial: they are arranged around a central point and may be similar.
2. Rhythm is organized movement. It allows the eyes to move from one part of a design to another. It can be achieved through repetition, graduation, and alternation.
3. Emphasis is the part of the design that catches the viewer's attention.
4. Proportion refers to the relationship between one part of a design and another part of the whole design. It is a comparison of sizes, shapes, and quantities.
5. Unity When things look tight together, you have created unity or harmony. Lines and shapes that repeat each other show unity (curved lines with curved shapes). Colors that have a common hue are harmonious. Textures that have a similar feel add to unity. But too much uniformity sometimes can be boring. Also, too much variety destroys unity.

Elements of Design

Design has individual elements which are part of every item. These include color, texture, line, shape, and form. Design is an overall plan or scheme.

1. Color is described with the words hue, value, and intensity.
 - Hue: refers to the name of the color
 - Value: tells the lightness or darkness of a hue
 - Intensity: refers to the brightness or dullness of a hue.
2. Line can be horizontal, vertical, dotted, zigzag, curved, straight, diagonal, bold, or fine. Lines can show direction, lead the eye, outline an object, divide a space, and communicate a feeling or emotion.

3. Texture is the surface quality that can be seen and felt. Textures can be rough or smooth, soft or hard. Textures do not always feel the way they look.
4. Shape is a closed line. Shapes can be geometric, like squares and circles; or organic, like free-formed shapes or natural shapes. Shapes are flat and can express length and width.
5. Form are three-dimensional shapes, expressing length, width, and depth. Balls, cylinders, boxes, and triangles are forms.
6. Space is the area between and around objects. The space around objects is often called negative space; negative space has shape. Space can also refer to the feeling of depth. Realspace is three-dimensional; in visual art when we can create the feeling or illusion of depth we call it space.

Conference Judging Day

1. Pick up your entry form at the front desk. Visit each judging area you are entered in to add your name to the waiting list. Then return to the shortest waiting list to get your projects judged. When you return to another department check in with that superintendent so they know you are back and able to be judged they will rotate through the list from the top when there is an open judge's table.
2. After all projects are judged, return the form to the checkout desk. Premiums are paid based on these sheets. No sheet turned in no premium.
3. All items are conference judged in each department. Conference judging takes place **between the exhibitor and the judge only**. Seating is available for parental viewing, but parents are not allowed at the judging table unless the judge has requested the parent to join.
4. All clubs, chapters, or groups with entries in this building are expected to display exhibits in a designated booth area for the entire fair.
5. Each judge holds back exhibits to be considered for awards and participates in the final selection decision.

Exhibit Rules

1. Duplication of **copyright material** or design should not be used in a 4-H exhibit that is presented as original work by the exhibitor. A copyright design cannot be displayed in a public setting (fair) without permission being granted by the owner of the copyright. When permission has been granted, the exhibit will be displayed and labeled appropriately. Those without permission **cannot** be displayed. Many school art projects using copyright material are not acceptable.
2. A **purchased copyrighted item** can be used in an exhibit. Exhibits made from purchased kits must be identified. Example: a purchased puppet showing a child safety point or a purchased poster of a Star Wars character which you framed.
3. Noxious weeds endangered or threatened wildflowers nest and small songbird feathers CAN NOT be used in any exhibit. Pheasant, duck, goose, and quail feathers "legally taken" are acceptable.
4. Any exhibit which includes a live plant must be in a water-proof container or include a drip saucer.

Awards

1. Blue, Red, White, Participation, Gold, State Fair, and State Fair Alternate ribbons are all assigned by the judge. This decision lies solely with the judge and is not the decision of the superintendents, 4-H volunteers, or extension staff.
2. Gold ribbons are awarded to outstanding exhibits in one of the following areas:
 - 4th grade
 - Horticulture exhibit
 - FFA member
 - Non-Original Art
3. State Fair and State Fair Alternates are limited to 4-H'ers who have completed 5th - 12th grades. Exhibits entered through FFA are not eligible for State Fair consideration.
4. Polk County is assigned a number of exhibits that can advance to the State Fair. This number is based on 4-H enrollment from the previous 4-H year. 4-H Staff then assigns how many exhibits can go in each area based on the number of exhibits entered in each department.

Creative Arts Department

ORIGINAL ART RULES

1. Exhibits made from kits or preformed molds will not be accepted. Exception: Preformed molds (greenware, whiteware) may be used to provide the appropriate surface for a process technique or application of original design.
2. If the exhibit is a finished art object, the source of inspiration of the design, design sketches, or other processes for creating the object and design must be included.
3. Original works of art must be a creative expression of a design unique to the artist or represent a significant modification to an existing design to make a new and original statement by the artist.
4. Exhibition of derivative works created by a 4-H'er is prohibited without the written permission of the original copyright holder/owner. Use of copyrighted or trademarked designs, images, logos, or materials in 4-H visual arts exhibits is prohibited unless written permission has been obtained from the copyright or trademark holder/owner. For additional information, see [4-H Exhibit Copyright](https://go.iastate.edu/BARCRL) (<https://go.iastate.edu/BARCRL>)
5. **Only three exhibits per medium** are accepted in visual art classes. **Examples of mediums** are paper, fiber, clay, leather, textiles, wood, glass, plastic, metal, carbon, chalk, pigment, and natural materials.
6. Subject matter of photographs must be in good taste and be appropriate for public display in a 4-H setting.

Clothing Event Department

- The Polk County Clothing Event judging will be held before the fair. Please check the [fair schedule](#) for the exact date commonly the first Saturday of July. A judging schedule will be sent to each participant. Exhibitors must be judged on this day, judging occurs with just the judge and exhibitor present.
- At Polk County Fair youth will have the opportunity to participate in the Fashion show, please check the [fair schedule](#) for the time and date.
- The exhibitor must wear the outfit for the judge on judging day, each event entry should have the clothing event reporting form, a commentary card, and a photograph. The form and card will be used for describing the outfit for judges, and for the fashion show at the County Fair. **Failure to include the form, card, and photograph will result in a lower ribbon placement.**

Fashion Revue

1. This class must have at least one major garment cut and construct, hand-knitted, machine-knitted, or crocheted by the exhibitor during the current 4-H year. (The constructed garment may be worn with a purchased garment See rule #4).
2. Outfit in this clothing event class cannot be shown in another clothing event class, this is due to the goal of the shopping trip should differ and not fit the goal for the clothing event area.
3. A garment or outfit consisting of one to three pieces such as party clothes, tailored suits, vest, slacks, shirt, skirt, active sportswear, and/or coats are acceptable as Fashion Revue entries.
4. Blouses, shirts, and sweaters are usually considered garments. If used to complete an outfit, they may be constructed or selected.
5. All other accessories and undergarments may be constructed or selected.
6. Garments modeled in Fashion Revue are eligible to be entered in the Clothing Department competition at the County Fair but are only eligible for State Fair in one class, either Clothing Event or as a clothing exhibit. Youth will have the option of which one advances.
7. The following senior entries may be selected for the Iowa State Fair. Four participants total with no more than two (2) participants with an entry in any given category (athletic wear, formal wear, everyday wear, costume).

Clothing Selection

1. This class includes a purchased outfit for any occasion selected by the entrant and worn for the judges. The garment for this class must be purchased and not constructed.
2. Outfit in this clothing event class cannot be shown in another clothing event class, this is due to the goal of the shopping trip should differ and not fit the goal for the clothing event area.
3. Outfits may be selected and/or purchased from any source, including consignment shops, used clothes stores, etc. Home-sewn clothing items are not eligible unless the completed garment was purchased from a used clothing source. Clothing items that are custom sewn specifically for the participant are not eligible.
4. Garments modeled in Clothing Selection may be entered in the Clothing Department at the County Fair but will only be eligible for State Fair in one class, either Clothing Event or as a clothing exhibit. Youth will have the option of which one advances.
5. The following senior entries may be selected for the Iowa State Fair. Four participants total with no more than two (2) participants with an entry in any given category (athletic wear, formal wear, everyday wear, costume).

\$20 Challenge

1. This class includes an outfit selected and/or purchased from a garage sale, consignment store, or resale shop. Clearance items at a store are not eligible for this division.
2. Outfit in this clothing event class cannot be shown in another clothing event class, this is due to the goal of the shopping trip should differ and not fit the goal for the clothing event area.
3. Exhibits in this class must meet these criteria and the total cost for the outfit must be \$20 or less (receipts must be turned in with the Clothing Event Report Form). Accessories and undergarments are not included in the \$20 limit, the main outfit only. Hand-me-downs or clothing as gifts that were selected by the 4-H'er belong in Clothing Selection.
4. Receipt(s) for every item included as a part of the calculated total must be submitted with the entry. A garage sale receipt can be a piece of paper with the name of the location such as "Jane Doe garage sale", the date, the amount paid, and the signature of the person selling at the garage sale. If the outfit was free at a garage sale, "free" can be listed on the report form and the receipt. Failure to provide receipts will be reflected in the score.

5. Garments modeled in the \$20 Challenge may be entered in the Clothing Department at the County Fair but will only be eligible for State Fair in one class, either \$20 Challenge or as a clothing exhibit. Youth will have the option of which one advances.
6. The following senior entries may be selected for the Iowa State Fair. Four participants total with no more than two (2) participants with an entry in any given category (athletic wear, formal wear, everyday wear, costume).

Innovative Design

1. The purpose of this class is to encourage creativity and out-of-the-box thinking when creating an outfit.
2. These designs can be theatrical costumes, cosplay, wearable technology, sustainable/upcycled fashion, accessible fashion, and/or outfits that use unconventional materials.
3. Outfit in this clothing event class cannot be shown in another clothing event class, this is due to the goal of the shopping trip should differ and not fit the goal for the clothing event area.
4. The outfit must be showcased as a worn garment modeled by the exhibitor or by the individual that it was designed for.
5. Exhibitors may make their garment entirely, or permanently alter the silhouette of pre-existing materials through some method of permanent alteration or addition.
6. Consideration is given to originality and innovation.
7. The following senior entries may be selected for the Iowa State Fair. Four participants total with no more than two (2) participants with an entry in any given category (athletic wear, formal wear, everyday wear, costume).

Communications Department

1. The Communications Division consists of the following exhibits: Educational Presentations, Working Exhibits, Extemporaneous Speaking, Share the Fun, and Posters.
2. The judging or evaluation for presentations, working exhibits, and extemporaneous speaking will take place in the 4-H Exhibit building, on the Tuesday of the county fair. Posters will be turned in on Conference Judging Day that day. The Share the Fun Contest will be Tuesday, at 6:00 PM in the 4-H Building Stage, during the County Fair.

Educational Presentations

1. An Educational Presentation is defined as any presentation that teaches or communicates a process, a fact, or an idea, through a showing and telling process to gain the desired response from an audience.
2. This presentation may be by demonstration, talk with visuals, skit, panel discussion, dialogue, or any method desired to best get the educational subject matter taught to the audience.
3. The presentation may be given by one or more members. The topic of the presentation should determine its length but should not exceed 20 minutes for intermediate and senior 4-H'ers. Junior presentations should not exceed 15 minutes.
4. All members involved in one presentation should be within the same age division, but if they are not, they must compete in the division of the oldest member.
5. If a member has been part of a team receiving top recognition at the Junior or Intermediate level, he or she must participate with different partners or individually while in the same age group. This does not apply to seniors.
6. Food products must be unquestionably safe to eat when they are used in a presentation.

Extemporaneous Speaking

1. This contest is designed to encourage the development of the life skill of communicating with others by enhancing the ability to think, organize, speak, and answer questions readily by participating 4-H'ers before an audience.
2. Participants must be senior 4-H'ers.
3. Contest format:
 - Thirty minutes before the program, each participant will draw three of the available topics, selecting one to speak on.
 - The selected topic will not be available to the other participants in the speaker's assigned room. The general nature of the topics will relate to 4-H. The other two topics drawn but not chosen will be returned to the available topics for the other participants.
 - A preparation room is to be used with one participant per speaking site admitted initially and one additional participant per speaking site admitted every 15 minutes as the program progresses. A participant may not leave the preparation room until it is time to speak, nor may a participant receive help from a parent, leader, other adults, or any other youth. A program official will assist participants with the time requirements.
 - All reference material will be screened by a program official on the following basis:
 - Participant may bring their own books, magazines, or newspaper clippings for reference during the thirty minutes of preparation.
 - Reference material must be printed material such as books or magazines (cannot be notes, outlines, or speeches prepared by the participant or by another person for use in this program).
 - Some relevant reference material will be available in the preparation room. This material will consist of historical material related to the 4-H program.
 - Each speech shall be the result of the 4-H'ers own efforts using approved reference material that a participant may bring to the preparation room. No other assistance may be provided. Plain 3"x5" note cards will be provided for each participant in the preparation room. If notes are used, the 3"x5" note cards provided must be used in delivering the speech.
 - Only notes made during the preparation period may be used.
 - Each speech shall be not less than four but no more than six minutes with five minutes additional time allowed for related questions, which shall be asked by the judge. The participant will be shown timecards in ascending order (1, 2, 3, 4, and 5) by the timekeeper. "Stop" will be said at six minutes.
 - The program timekeeper will introduce each participant by name and the county he/she represents. The participant will be expected to introduce his/her speech by title only.
 - Participants are not permitted to use any props, gadgets, posters, or audiovisuals of any sort. A podium will not be available.
4. Speeches will be evaluated using the following criteria:
 - Content related to the topic.
 - Knowledge of the subject.
 - Organization of material.
 - Power of expression.
 - Voice.
 - Stage presence.
 - General effect.
 - Response to questions.
5. A judge's critique/conference with each participant will be included as a part of the program.

Shooting Sports Competition

General Rules

1. Eligibility:
 - a. Each participant must be a 4-H or FFA member in good standing.
 - b. Participants must have passed the required coursework for the discipline that they will compete in or attended a hunter's safety course.
2. Age categories for participants:
 - Seniors - 9th, 10th, 11th, or 12th graders prior school year
 - Intermediates - 7th and 8th graders prior school year
 - Juniors - 4th, 5th, or 6th graders prior school year
3. Coaching: No coaching will be allowed when shooting for record.
4. Event—
 - Registration- Due July 1
 - Competition Date-
 - Time-
 - Location- Ankeny Izaak Walton League, 4857 NE 110th Ave, Elkhart, IA 50073
 - Awards- July 19, 5:45 pm
5. Equipment: Shooting Equipment will be available for use. Club equipment will be sanitized after each participant. (Club genesis bows, shotguns, and small-bore rifles.) Rifle and shotgun ammunition will not be provided due to the short supply.
6. Please follow social distancing and sanitation procedures. Wearing masks is recommended. On the archery range masks will be required the day of the event.
7. Safety: For safety and consideration to others, all participants will abide by accepted safety rules and all specific range and event rules, or they will be disqualified. Enforcement of these rules is the responsibility of the range officer and all coaches.
8. Rules: No harassment of a participant, by anyone, will be tolerated. If done by another participant, they will be disqualified and ejected from the competition. If done by a spectator, the spectator will be ejected.
9. All questions and rulings will be the responsibility of the match director or designated match personnel.

Archery -

10. Target: Single-spot 40cm or 5-spot NFAA paper target. Scoring: Single-spot 5-4-3-2-1; 5-spot 5-4-0. Scores will include a total plus the number of Xs which are used as tie-breakers. Once the selected target is posted, the type of target can't be changed.
11. Course of fire: 30 arrows shot from the 20-yard line for Seniors and Intermediates, 10 yards for the Juniors. 6 ends of 5 arrows.
12. Time limit: Time limit: There will be a four (4) minute time limit per end. Any arrow shot after the buzzer will be counted as a miss.
13. Scoring: Double scoring will be used with a minimum of three (3) shooters per target bale.
 - a. Each group will appoint two scorekeepers, also a target captain who will call arrows will be appointed.
 - b. Shooters who disagree with the target captain's call may ask for the Range Officer to call the disputed arrow. Match Director's call will be final.
 - c. Arrows and target face may not be touched until all arrows on the bale are scored.
 - d. An arrow needs only to touch the line to receive the higher point value.
 - e. If a shooter inadvertently shoots 6 arrows in an end, the highest scoring arrow will be disqualified.
14. Equipment failure time of 15 minutes will be allowed with notification of failure to Range Officer. The archer will be allowed to shoot any arrows not completed – after the end. One practice arrow end (5 arrows) will be allowed after the repair is completed and before scoring continues. If equipment is not repaired within the allotted time, the shooter must take a score before equipment failure.
15. Match Equipment Standard:
 - Traditional /Barebow – any non-compound bow with no sights, no devices including an overdraw stop on the cam, nothing added to the bow, fingers must be in contact with the arrow. No string peeps and

no mechanical release aids are permitted. This class would include Genesis, longbows, and recurve bows without sights, stabilizers, or other accessories.

- Freestyle - any non-compound bow with accessories. One adjustable sight pin, clicker, and kissers button are permitted, torque compensators are permitted. This class would include Genesis, longbows, and recurve bows with any type of attachment.
- Compound - release aids permitted, overdraws may not place the arrow rest further than 6 cm from the pivot point of the bow, string peeps, optical sights, and stabilizers of any size are permitted, spirit levels are permitted. 60 lb. maximum draw weight.
- Arrows – NO HUNTING POINTS! Arrows will not be permitted to lie on the ground. Hip-mounted quivers are preferred, bow-mounted or ground (arrow tube) quivers are permissible. The range is equipped with some ground quivers if required.

Smallbore Rifle -

1. Rifle: Any type of 22-caliber rimfire rifle capable of loading one round at a time is allowed. Single-shot bolt or lever-action rifles are preferred; however, any action type tube-feed, clip feed, and semiautomatic rifles can be used, if it can be demonstrated that they can be loaded one round at a time in a safe manner. The competitor will not be allowed to place any portion of their body in front of the muzzle during the loading process. It is up to the competitor to have the rifle approved before competing. The range safety officer will have the final approval. Any safety violation will result in disqualification.
 - a. Standard velocity, match or target .22 ammunition is required.
 - b. No set or electric triggers will be allowed.
 - c. Open or aperture sights only. No scopes allowed.
 - d. Thumbhole stocks, palm rests, heel rests, Scheutzen-type, and hooked butt plates are prohibited.
 - e. Trigger pulls - any safe trigger is allowed. A safe trigger does not allow the hammer or firing pin to fall except by a deliberate pull of the trigger by the shooter.
 - f. Adjustable butt plate must be in-the-home or neutral position. Pliable cheekpieces may be added to stock for fit. Factory-installed stock may be altered for length.
 - g. The same rifle must be used for all positions of fire, except in the case of a malfunction or disabled rifle.
 - h. Smallbore rifles must have an empty chamber indicator (ECI).
 - i. Portable stands to rest your rifle on between shots in offhand is recommended.
2. Clothing: Shooting gloves on the weak hand, coats, jackets, slings are permissible. Shooting pants or shoes are not allowed.
3. Spotting Scopes: Spotting scopes or binoculars may be used throughout the match.
4. Sling: Slings may be used except in the standing position.
5. Target type: A-17 at 50 ft.
6. Kneeling Rolls: Kneeling rolls and range mats are recommended. Pliable material not to exceed 7" diameter by 9½" length.
7. Course of Fire: Five-minute sight-in, in any position. Ten shots prone, standing and kneeling in that order of fire. This applies to Juniors, Intermediates, and Seniors.
8. Time Limit: 1½ minutes per record shot prone, 1½ minutes per record shot kneeling, 2 minutes per record shot standing.
9. Except as specified above NRA rules will be followed, [NRA Smallbore Rifle Rules \(http://rulebooks.nra.org/documents/pdf/compete/RuleBooks/SBR/sbr-book.pdf\)](http://rulebooks.nra.org/documents/pdf/compete/RuleBooks/SBR/sbr-book.pdf)
10. For all Smallbore competitions a 10-minute limit will be allowed with as many shots as needed in the sighting bull(s) on the first target.
11. No sight in shots will be allowed on subsequent targets in the same discipline.
12. Only ten shots for record shall be shot at any target.
13. If more than ten shots are fired into one target the ten lowest scores shall be counted (this includes those scored as zero whether on the target face or cardboard backing.) 8
14. Example A: if a shooter accidentally shoots twice at one bull on a target he/she must skip one bull (to keep from shooting more than 10 shots at one target)
15. Example B: all shots on the target that hit between the bulls and do not touch the scoring rings of any bull will be scored "0". (i.e. If 11 or more shots are fired into a target, only the 10 lowest scores will count – this includes those scored as zero whether on the target face or cardboard backing.)

16. There will be no penalty points assessed for excessive shots (more than 10 on a target) but only the 10 lowest shots will be scored.
17. There is no 'X' in Smallbore A-17 targets. The center ring is a 10.
18. All targets must be labeled with your name, date, and position (prone, standing, kneeling/sitting).

Shotgun -

1. Target: Per Amateur Trapshooting Association rules
2. Distance: 16 yards
3. Course of fire: Shooters will shoot 25 targets. Targets will be shot and scored in rounds of 25.
4. Equipment: Any 12 or 20 ga. shotgun using 2 ¾ inches shotshells with number 8 or 7 1/2 shot. Shells cannot have a shot load greater than 1 1/8 oz and the velocity must not exceed 1290 ft per second or 1325 ft per second for a 1 oz. load.
5. Rules: Amateur Trapshooting Association rules. Please note that all shooters must be 12 years old as per state rules to participate in the shotgun event.

Muzzleloader - Black Powder

1. Target: NMLRA Novelty Bottle Target (TG2427)
2. Distance: One target at 25 yards.
3. Course of Fire: 10 record shots two per bottle
4. Time Limit: A total of 60 minutes for the match.
5. Equipment: Caliber -.54 max, Ignition - No. 11 percussion cap, musket cap, or 209 primers. No flintlock. Traditional or in-line rifles. "Set" or "double" triggers are not permissible. • Sights - Open iron, aperture, and fiber optic sights will be permitted. No optical, telescopic, or electronic sights. Powders: Pyrodex RS, Triple Seven, or other equivalent black powder substitute OR 3f black powder. Bring powder in the original container and show it to range officials for approval before dispensing it into a powder flask/horn. Caps/capper and powder must be checked-in with the range officer when you arrive on the range.
6. Projectile: Patched soft lead round ball only, using no more than 60 grains of loose powder
7. Scoring Bottles: As outlined on the target. Completely within neck-10 pts; nicking the neck-7 pts; within body-5 pts; nicking the body -3 pts.
8. Rules: NMLRA Muzzle Loading Rifle. <http://www.nmlra.org>
 - a. Each shooter will shoot from a standing position only.
 - b. All loading will be done at the loading table by the shooter under the supervision of a coach, leader, or parent. The powder container must be capped immediately after filling the powder measure. No loading directly from the powder container to the rifle is permitted.
 - c. After loading, wait until the Range Officer gives the command to approach the firing line.
 - d. Do not cap the rifle until the range officer authorizes it.
 - e. After firing the shooter will return to the loading table and insert the range rod. Then he/she may begin preparation for loading. No blowing down the barrel!
9. Hang Fire: Notify range officer immediately. Keep rifle pointed down range a minimum of 2 minutes. Range Officer will take charge of clearing round from the chamber with silent ball discharge. This will not be considered an equipment failure. A dirty, un-fireable firearm will be considered equipment failure after the second attempt to fire. The firearm will not be cleaned by the Range Officer. The 20-minute time limit would begin after the second attempt is cleared by the Range Officer. A safe area will be provided and can be used as a pre-shoot cleaning and preparation area.

3. All fair entries including Open Livestock are to be made in [FairEntry](http://polkcountyfair.fairentry.com) (<http://polkcountyfair.fairentry.com>) before or on July 1 by 11:59 pm. No Paper forms will be accepted.
4. Late entries can be made for 2 business days following July 1. A \$50.00 per day fee will be assessed for late entries. After the 2-day late registration period, youth must contact the Fair board President to attend the Fair board meeting and ask permission to exhibit at the fair. Upon the Fair board's decision, a final fee will be decided.
5. All late entries must be filled out in the office. Late entries must be paid in cash or check.
6. Youth should bring their exhibit(s) on Saturday, from 8:30 AM - 2:00 PM an optional interview will be available with a caring adult in the show and tell fashion.
7. Youth may enter class CK1 once. Multiple exhibits may be shown, but youth will only receive one participation ribbon for the entire grouping. 3. Candidates will be required to fill out the contest application and send it in by May 15th.
4. Interviews will only be conducted in person on the judging day. Judging day varies year to year and can be found [online \(polkcountyfairiowa.com\)](http://polkcountyfairiowa.com)
5. Contestants will be split into interview groups.
 - a. They will have an individual interview with a panel of judges.
 - b. They will also participate in a group interview.
 - c. Youth should be prepared to be at the extension office for at least 2 hrs.
6. No professional model (one who has had ongoing employment in which modeling was the primary part of the job) is eligible to compete in the Polk County contest.
7. Any contestant who has competed in the State Fair Queen Contest may not compete in our County contest again.
8. The king and queen will be crowned at the County Fair Barbecue check schedule for date and time. The queen/king and her/his court will be required to hand out ribbons throughout the county fair and help at the Livestock Auction.
9. The queen is expected to participate in the State Fair Queen Contest and meet their requirements. You may not compete in any other titled contest at the Iowa State Fair. (You may still show your 4-H or FFA entries). The fee is paid by the Polk County Fair Board and Polk County Farm Bureau. Polk County Fair Queen cannot compete at the State Fair, the first runner-up will take her responsibilities.
10. The queen and king and their court will always act professionally. (Example, no smoking or drinking allowed and must adhere to all the fair rules and regulations.) If there is a question as to the professionalism of an individual, that person will forfeit their title.
11. The queen/king and their court will not be allowed to wear their crown or sashes while showing livestock or other projects.
12. The queen/king and their court will always wear proper attire (nice dress clothes).
13. The queen/king and their court will be present at all events they are assigned to, as well as other events as scheduled by the queen/king superintendent.
14. All court members will arrive on time to assigned events and be present throughout the entire event unless other arrangements have been made with the queen/king superintendent.
15. The queen/king and their court will always hold a cheerful and positive attitude.
16. Queen and King will be participating in Kiss the Pig contest during the fair.

Junior Prince and Princess Contest

1. Each club or chapter may nominate one young woman and man, grade 7-15 years of age to compete in the contest judging.
2. Candidates will be required to fill out the contest application and send it in by May 15th.
3. No professional model (one who has had ongoing employment in which modeling was the primary part of the job) is eligible to compete in the Polk County contest.
4. The king and queen will be crowned at the County Fair Barbecue check schedule for date and time. The Junior Prince and Junior Princess will be required to hand out ribbons throughout the county fair.
5. The Junior Prince and Junior Princess will always act professionally. (Example, no smoking or drinking allowed and must adhere to all the fair rules and regulations.) If there is a question as to the professionalism of an individual, that person will forfeit their title.
6. The Junior Prince and Junior Princess will not be allowed to wear their crown or sashes while showing livestock or other projects.
7. The Junior Prince and Junior Princess and their court will always wear proper attire (nice dress clothes).
8. The Junior Prince and Junior Princess will always hold a cheerful and positive attitude.

Anything Goes Contest

Superintendent: 4-H County Council

1. Entry Fee: \$1.00 per club due at sign-up at the event.
2. The County Council is sponsoring the Anything Goes Contest on Sunday at 6:00 PM in the horse arena.
3. The inter-club competition between the clubs/chapters is for youth in 4th - 12th grade.
4. All participants must be enrolled in Polk County 4-H or FFA
5. It is an Olympic-style competition with cash prizes, lots of fun, and even some surprises.
6. There may be contests such as Egg Toss, Orange race, Obstacle Course, Tug of War, and others.
7. Must have a leader or an adult in attendance with club members.

Decorate-A-Bale Contest

Superintendent – 4-H County Council

1. Entry Fees - \$1.00 per bale to be collected at the event. Entry Tag – must be attached to the Bale twine. Entry tags are available at Exhibit Building Office.
2. This class is for anyone (no age limits). Exhibits can be prepared by an individual exhibitor, a team of exhibitors or may be the result of a group effort.
 - a. At least one member of the group must be present during judging, 10 AM Monday.
3. Only One bale may be used per exhibit (straw, hay, grass, or bean straw – small size bale only.)
4. Contact a County Council member if you need a bale.
5. Decorations must be in good taste and not offensive.
6. Bales must be in place by 9:30 AM Monday.
7. Bales may be decorated Sunday. However please be aware animals weigh-ins by being going on and bales are not in a protected area. No Bales should be in the 4-H exhibit building. Bales must remain on the fairgrounds until Thursday at 3:00 PM
8. Judging will be done according to originality, creativity, etc.
 - \$20.00 first place.
 - \$ 10.00-second place.
 - \$5.00 third place.
9. Fair board is not responsible for damages to the bale or injuries.

Little Tykes Tractor Pull

Superintendent:

1. Any youth ages 4 - 12 years may compete.
2. \$1.00 Entry fee per youth.
3. No Flip Flops Allowed
4. Parent or guardian must sign a waiver and must be present during the contest.

Open Class Department

1. \$4 Entry Fee per Class. Ribbons only, no premiums.
2. This division is open to all Polk County residents.
3. Exhibitors are permitted an unlimited number of entries per class in this department.
4. All exhibits must be brought to the fairgrounds between 9:00 am - 12:00 Noon, Saturday.
5. All exhibits must remain in open class display for the duration of the fair. All exhibits will be released Thursday at 4:00 -5:00 PM Superintendents will not be responsible for any exhibit after 5:00 pm Thursday.
6. Blue, Red, and White ribbons will be given to all qualified entries. No premiums will be paid in these classes.
7. Best in Class and Best in Division Ribbons will only be awarded if merited and at the sole discretion of the Open Class Judge(s).
8. All exhibits must be fresh and clean.
9. Exhibitors 17 years old and under will be entered as a youth exhibit using the same class numbers, (i.e., Class #OP220-Y). All youth entries must enter their age on the entry tag.

Open Class Horticulture Division

1. Criteria for the exhibition are quality, condition, representativeness, and uniformity.
2. The exhibitor should first select specimens that are as near physically perfect as possible, free from insect and disease injury, and high in quality. Then choose from this selection those specimens which combine the ideal characteristics of the fruit or vegetable, and which are most uniform in size, color, and other characteristics.
3. It is highly recommended that exhibitors prepare their vegetables for the exhibit as described in the publication 4H-462, entitled "Harvesting and Preparing Vegetables for Exhibit" available on the Polk County Fair Website for download or at the Polk County Extension Office.
4. For flower exhibits: all specimen flowers must be grown by the exhibitor. Furnish own containers. Fresh plant material is required unless otherwise specified.

Open Class Fine Arts Division

1. The work must be original work executed in the past calendar year. "Original" means that the artist has used his/her concepts, ideas, and techniques for the execution of the artwork. The artist has not copied the ideas, techniques OR exactly duplicated the subject matter of another artist's work. Exception OP 405.
2. All work submitted must have a finished appearance; the media with which it is executed must be completely dry.
3. If the work is two-dimensional, it must not exceed 52" (4 feet, 6 inches) in either length or width. All two-dimensional adult work done with oil or acrylic paint must be presented framed, a canvas stretched on a wooded frame is considered framed; work done in pastels, watercolor, drawings, and prints must be framed, covered with glass or Plexiglas.
4. Three-dimensional work will not be accepted if it exceeds 60" (5 feet) in any direction, is excessively fragile or heavy. Three-dimensional work must be presented on a sturdy base. A Canvas stretched on a wood frame is an acceptable base.

Open Class Foods Division

1. All entries in the Food Department must be the product of the exhibitor, made in the home kitchen, and not a means of livelihood.
2. Any exhibit considered to be a food safety risk or portray a food safety risk will not be accepted, judged, or displayed.
3. All food products/exhibits should be appropriate for human consumption.
4. Food product exhibits must be prepared, baked, or cooked using only food-grade utensils and containers.
5. Products that require refrigeration will not be accepted, judged, or displayed. Meat jerky products are prohibited.
6. The recipe must be included for any prepared food exhibit; credit the source of the recipe.
7. Only food processed in the last calendar year is acceptable. Current USDA and/or Iowa State University guidelines for home food preservation must be used. For more information call the ISU Answer Line at 1-800-262-3804.
8. Preserved food exhibits must include two product samples. One will be opened for evaluation and discarded; the second will be placed on display and returned to the exhibitor. All perishable food products will be discarded when removed from display.
9. Prepared foods should be placed on a firm disposable plate or flat cardboard. Place food product exhibit in an enclosable plastic bag with an entry tag fastened outside the bag.
